FAQ ?

- Q What is Waaree Energies Ltd. "Waaree Prime" registered participant's loyalty program?
A "Waaree Prime" registered participants loyalty program is for registered participants with this program, the registered participants will be rewarded with rewards for recommending and getting sales done for Waaree Energies Ltd.s
- Q Is there any enrolment fee?
A No there is no enrolment fees.
- Q How to approach Waaree Energies Ltd. to get enrolled in this program?
A There are three ways to enrol yourself in this program:

 - Toll Free number
- Q How to download the Waaree Energies Ltd. mobile application?
A The application is available on Google Play Store for android phone users and IOS users can get the application on IOS App store.
- Q What are redemption options available for the registered participants?
A Registered participants can redeem gifts using Waaree Energies Ltd. mobile app
- Q How do I get the replacement of broken or damaged gifts, which I claimed for redemption against my points?
A Waaree Energies Ltd. program centre will make every possible effort to ensure that the gift reach to you in a safe condition. At the moment when the Gift is received by registered participants, it is recommended that gift should be opened and checked properly i.e. working, damage and breakage. If any issue found in relation to product damage then, it has to be reported within 24 hours from receiving, to Program centre, in an official mail along with images of broken product. If any damage is not reported within 24 hours from receiving, then Waaree Energies Ltd. or its representing agency will not be liable for any claims.

TERMS AND CONDITIONS

- In all the terms and conditions Waaree Energies Ltd. is termed as Waaree.
- This program is limited for the participants who are registered with Waaree Energies Ltd.
- This program can be either 'extended' or 'closed' at the sole discretion of the management. The participants will have no right to challenge the discretion of the management.

A Program Member Account is deemed to be inactive if points are not earned in connection with such Account for 10 years. Once an Account is deemed to be inactive, all points in such Account may, in Waaree's sole discretion, be deemed to have been forfeited by Waaree, with or without notice.
- If a Membership Number is used by any other person, all points relating to purchases made by such other person will be credited to the Member's Account. Waaree assumes no liability or responsibility for points redeemed by any person(s) prior to a notification to the Waaree's Customer Service Centre that the Membership Number has been compromised. Any points redeemed prior to notification shall be at the registered participant's risk.
- The points will have no cash value and are not exchangeable for cash. The accumulation of points does not entitle the Program's registered participants to any vested rights, and Waaree does not guarantee in any way the continued availability of any reward, redemption level, rebate or any other benefit.
